Advance set-up 8-12 March 2018

We provide parking spaces for a fee for cars with a gross vehicle weight rating of up to 2.5 t. Please use the Shop for Exhibitor Services to make your reservations by no later than six weeks before the start of the event. It may not be possible to honour orders made after this time. We provide parking spaces on the exhibition grounds for car trailers for a fee. These must also be ordered through the Shop for Exhibitor Services by no later than six weeks before the start of the event.

Trade fair 18-22 March 2018

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. All other vehicles will only be allowed to enter with a valid parking permit.

Trade fair 23 March 2018 (last day of the trade fair)

On the last day of the trade fair, entry will not be permitted after 2:00 p.m. From 2:00 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds. Dismantling vehicles should please head to the assembly point at the Rebstock car park.

This is the only place where you can obtain a dismantling vehicle pass.

On 23 March 2018 from 3:00 until 10:00 p.m. a free shuttle bus service will run between the Galleria entrance and Stop 4 (Haltepunkt 4) at the truck assembly point at the Rebstock car park.

Special dismantling vehicle passes

The trade fair ends at 5:00 p.m. on the final day of the event. On 23 March 2018 from 5:00 to 7:00 p.m., we offer you the opportunity to remove small items in advance of general admission for dismantling vehicles. We will be issuing a limited number of special dismantling vehicle passes for cars and vans up to 3.5 t gross vehicle weight rating during last two days of set-up and during the trade fair itself until all have been taken.

You can obtain these special dismantling vehicle passes at the Central Information Desk on Level 03 of the Torhaus by signing a declaration that you will be charged an additional €200.00 when invoiced for your ancillary costs if you do not leave the exhibition grounds with your vehicle by the deadline specified in the pass. Special dismantling vehicle passes will only be issued to exhibitors upon presentation of an exhibitor ID and customer number. The number of these passes is limited to a maximum of 400, so we recommend that you obtain yours as early as possible. They cannot be ordered in advance.

Entry starting at 5:00 p.m. and departure by no later than 7:00 p.m. are only possible at the gate specified on the pass. If you leave the exhibition grounds with your vehicle by 8:00 p.m., you will not be charged for your special dismantling vehicle pass. For departures after 7:00 p.m., your pass serves as your receipt and we will include a \notin 200.00 charge with your ancillary costs invoice. Please note that you will not be able to use the goods lifts due to the fact that the removal of the aisle carpeting from the exhibition halls and delivery of empty packing materials by the Logistics Service take place at the same time.

Entry for vans and trucks up to 7.49 t from 23 March 2018 at 7:30 p.m. to 24 March 2018 at 3:00 a.m.

Entry for vehicles with a gross vehicle weight rating of up to 7.49 t from 23 March 2018 at 7:30 p.m. from the truck assembly point, departure by no later than 24 March 2018 at 3:00 a.m. Vehicles that are still on the exhibition grounds after 3:00 a.m. will be towed away without prior notice at the owner's expense.

Entry for cars from 23 March 2018 at 7:30 p.m. to 24 March 2018 at 8:00 a.m.

Cars may only drive to parking levels P4 and P9.

No vans or trucks may enter on 23 March 2018 from 3:00 to 8:00 a.m.

On 24 March 2018 from 3:00 to 8:00 a.m. it is not possible to drive to the exhibition halls due to empty packing materials night.
